1. INTRODUCTION AND PROJECT REQUIREMENTS

Coalitions and Collaboratives, Inc. (COCO) is seeking bids to review, edit and produce the final design of the newly created Mitigation Pocket Guide. The selected contractor must be willing to work collaboratively with COCO during the course of the contract. This project shall be completed no later than October 1, 2021.

The Mitigation Pocket Guide is currently in Microsoft Word format and is 159 pages. Information is presented in a variety of ways, including; tables, check lists, bulleted information and short paragraphs. The selected contractor will review the document for grammatical errors, create complimentary formatting throughout the entire document and present a final document that is ready for print.

3. CONTRACT AWARD

Bids shall be considered by COCO based on cost of project, contractor integrity, record of past performance, and the best overall value to COCO. Bidders with wildfire management/program experience may be well suited for this project due to content. COCO reserves the right to accept or reject any or all bids, waive formalities in the bidding, waive irregularities in any or all bids, and make a bid award deemed to be in the best interest of COCO.

4. SUBMITTAL REQUIREMENTS

All bids shall be submitted via email to <u>jonathan@cusp.ws</u> and should include an attached PDF document with the bid description. The entire cost of preparing and providing bid responses shall be borne by the bidder.

COCO requires the following information to be included in the submittal for this contract:

1. One page PDF document outlining the cost and timeline for project completion. Include any experience, skills and certificates and a sample of work.
