

AIM Grant Concept Paper Budget and Match Examples

The AIM Team would like to clarify the cash match requirement for fuel reduction projects on non federal land. The required cash match from private landowners is 50% of the cost of the project on the property. Exceptions to this requirement may be made if working with disadvantaged communities or at-risk populations, however you will still need to show a 1-to-1 match on the entirety of your grant request.

Budget Example #1:

Request: \$10,000.00 grant funds <u>\$10,000.00 match</u> \$20,000.00 – *Total Project Value*

If the entire \$10,000.00 is to be spent on mitigation services (chipping or mitigation projects) then at least 50% of the match or \$5,000.00 must be a cash match from the homeowners or HOA. The other 50% can be either in-kind or cash. If you had 67 people participate in a chipping event that equates to just under \$75.00 per person. That really is not much to ask for the convenience of having someone come to your property and chip material versus having to haul the material away, especially if the landfill is not nearby or you don't have a vehicle to transport the material, or having to rent a chipper and do the work yourself.

Budget Example #2: Request: \$75,000.00 grant funds <u>\$75,000.00 match</u> \$150,000.00 – *Total Project Value*

Your AIM grant includes personnel time and contractor time to reduce fuels on private lands (chipping, defensible space, fuel break etc.). You are asking for \$75,000.00 from AIM and need to show \$75,000.00 in match. Since \$30,000.00 of your grant ask is going to reduce fuels on non federal lands, you show a \$15,000.00 cash match contribution from landowners. The remainder of the match (\$60,000.00) can be from cash or in-kind sources.
