Our funding is specifically focused on wildfire mitigation. If you have more questions, please reach out to us at aim@co-co.org . Thank you!
	We are planning to submit a proposal that would fund wildfire resiliency work across mutliple land management non-profits, including a native botanic garden. We were planning on having the botanic garden be the lead applicant because they can provide the biggest match in terms of volunteer hours (biggest community buy-in), but would it be more advantageous to have our local Wildfire Resiliency Collaborative be the lead applicant because of their specific focus on wildfire resiliency? How much weight does the lead applicant carry?	Please reach out to us at aim@co-co.org so we can get more detail. Even if the local WRC is the lead applicant there may be a way to still capture the match from the land management nonprofit.
	ArcGIS (maping software) has a yearly fee associated with it, could applicants use the equipment portion of the AIM Grant to cover this for multiple years on a single grant? The basic ArcGIS is \$700/yr - 7 years would be \$4,900 which is under the \$5,000.	The AIM Grant is a reuimbursement process that takes place within the contract agreement dates. Once the agreement is active, there is one year to utilize the funds. Unfortunately pre or post dating funds falls outside of the federal reimbursement guidelines.

11	Does time for staff need to be listed per staff in the budget narrative?	This is recommended to provide as much transparency and detail to the narrative you feel is needed to help the COCO team understand the full scope while reviewing the concept papers.
	Can SRS Title 3 funds be used for the 1:1 match?	It is my understanding that these are federally sourced funds so no, it cannot be used for the 1:1 match.
	For capacity building, could a fire district utilize this grant for seasonal wildfire firefighter personnel? Duties including suppression and mitigation activities.	This hits on the capacity building concept well, utilize the tipping point concept on sharing this proposal.
14	Michaele just stated about the 50% private landowner match for mitigation work. Would CoCo also apply that line of thought regarding the costs of doing home hazard assessments on private parcels?	No, it does not necessarily apply to home hazarad assessments - the 50% landowner match refers more specifically to mitigation work being done on the homeowner's property.
	Our mitigation work consists of organizing volunteers to perform work on one another's private lands. No cash changes hands, and no contractors are involved. The landowners do provide some in-kind match in terms of their own time and equipment, but we don't have a hard requirement for how much. We don't need to start asking the landowners to provide cash in exchange for participating in the program, do we?
