AIM Grant Eligibility

The AIM Grant is a <u>12-month</u> capacity building grant opportunity open to:

- → Non-profit organizations with 501c3 status
- → Collaborative groups
- → Cities & Counties
- → Conservation Districts
- → Fire Departments
- → Tribal Nations

Organizations listed above must be working to advance wildfire resiliency within their communities. If your organization type is not listed above, please send an email to Wendie Warner at Wendie.Warner@co-co.org.

Applicants *must* also be eligible to receive federal funding & have an active UEID Number at the time of Award.

AIM Grant Guiding Principles

The AIM Team believes in supporting sustainable organizations & programs that reduce the wildfire risk & lead to community resilience. We're about BUILDING CAPACITY.

Key components of this include:

- Local people solving local problems by using best-known practices to create place-based solutions.
- Residents & communities taking ownership in the effort by committing time, equipment & financial resources.
- Working together & sharing resources to build resilient communities.



What is Capacity Building?

Capacity building (or capacity development) is the process by which individuals and organizations obtain, improve, and retain the skills, knowledge, tools, equipment, and other resources needed to do their jobs competently. It allows individuals and organizations to perform at a greater capacity (larger scale, larger audience, *larger impact*, etc).



Building Capacity

- → Staffing: The demand on your program exceeds current staffing, need to hire new staff, support existing staff members
- → Planning Efforts: Starting a new CWPP, conducting Community Assessments or Home Assessments, Neighborhood Ambassador programs
- → Equipment under \$5,000: Building a fuels crew but lacking the necessary equipment: trailers, chainsaws, technology (hardware &/or software)



Funding Categories

Applicants can request \$10,000 - \$75,000 for Capacity Building projects under one or more of the following categories. All projects must be matched 100% (cash or in-kind).


- → Personnel (New or Existing)
- → Planning Efforts
- → Reduction of Hazardous Fuels
- → Mitigation Equipment under \$5,000

Priority will be given to proposals that clearly demonstrate how the organization's capacity will be increased versus proposals that just treat acres.



Tipping Point Projects

Projects that increase momentum or improve your efficiency & effectiveness - allowing you to ultimately get more work done on the ground.





Tipping Point Projects

- → Mitigation: Clearly articulate how the proposed mitigation project will increase your organization's capacity. Include anticipated acres treated, but clearly describe how completing this project fills in a much needed gap and/or will allow for more projects & outcomes in the future.
 - Chipping/slash removal program
 - Demonstration site
 - Key cross-boundary project connections
 - Cost-share program
 - Mitigation on private land will require a 50% cash match from the landowner (proof of underserved community may decrease this percentage)

As you work on your concept paper...

Make a compelling case about how the demand on your program exceeds the current capacity level.

- → Need a new position to process reimbursement requests & reporting
- → Current fuels crew is lacking technical supplies to move forward
- → Your organization has an increase of funding for mitigation on the ground & not enough funding for personnel to support the projects
- → Funding for an essential position is or will be lost

How will this ask push you over the tipping point & why is other funding not available?



Filling Out the Budget & Narrative

Indirect Fee

- \rightarrow The maximum request amount is \$75,000.
- → Indirect Fees can be up to 15% of the total project cost, not 15% of the maximum request amount.
 - Project Cost + Indirect Fee = \$75,000
 - ◆ \$30,000 + \$4,500 Indirect = \$34,500 Total AIM Request

*If you have an approved negotiated indirect cost rate agreement (NICRA), please include NICRA documentation with request.



Budget Narrative

Please list out how each dollar of AIM funds will be spent.

- → Personnel: Requesting \$7,500 (\$25/hour x 300 hours) for Wildfire Mitigation Specialist' time
- → Equipment: Requesting \$1,000 to purchase 3 chainsaws
- → Mileage: Requesting 500 miles at current federal mileage rate of \$0.70/mile.
- → Leveraged Match: federal funds contributing to the project but cannot count towards the 1:1 match

Matching Contributions Table Instructions: Please complete the Matching Contributions table below. Use the "Fill In Name" spaces to input the names of the organization/entity, adding their associated match amount in the appropriate space in the column below. If your proposal involves chipping / mitigation work that benefits resident's properties, you must include a 50% cash match from the resident (may be decreased with proof of disadvantaged community). Because AIM funding is federal funding, you may not use federal funds for your match. Other Federal funding sources are shown as "Leveraged Match" that add value to the project, but do not count toward the 1:1 required match for an AIM Award.

- → Final report
 - Photos, spatial data (GIS shapefiles), final outcomes table
 expense report & narrative
